



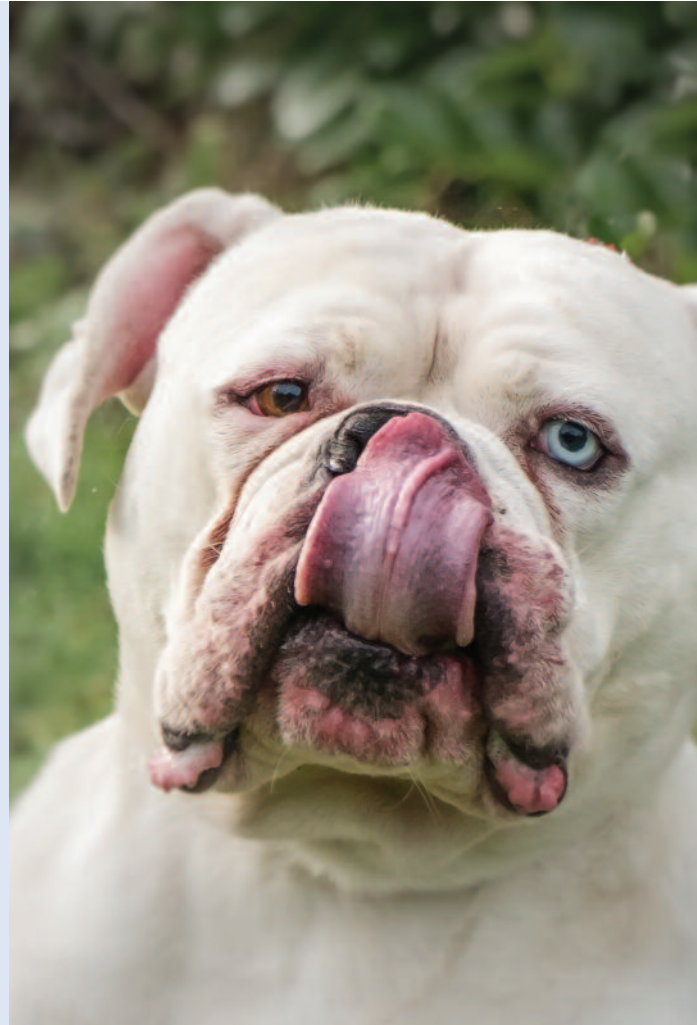



Chairperson's Statement

In 2015, the ISPCA received over 15,000 calls to our National Cruelty Helpline, a slight reduction on previous years. However, the number of calls requiring investigation continues to rise, which is both disappointing in that animal cruelty continues to occur in Ireland, but also rewarding in that the public are increasingly intolerant of poor animal welfare standards.

Preventing cruelty and enforcing animal welfare legislation is one of the principal strategic objectives of the ISPCA and accordingly we expanded the coverage of our Inspectorate in 2015 to 17 counties. We hope to further increase coverage over the next few years. Throughout 2015, our Inspectors played a huge part in driving up animal welfare standards across Ireland, and in particular in relation to Dog Breeding Establishments, which continue to be a cause for concern.

I would like to thank all of the ISPCA's staff and volunteers, the Member Societies who carry on so much wonderful rescue, rehabilitation and rehoming work, and the many donors who support the ISPCA. I would also like to acknowledge the support we received in 2015 from Simon Coveney, the then Minister for Agriculture, Food and Marine, and from his department.

CEO Report 2015

2015 was another busy and challenging year for the ISPCA but also a very rewarding one. Our National Animal Cruelty Helpline received over 15,000 calls, over 3000 of which were cruelty allegations that required investigation by our Inspectors or affiliated Member Societies in counties where we do not currently have an ISPCA Inspector. Our Inspectors initiated 35 animal welfare related prosecutions, more than any other organisation or agency in Ireland. Nine cases were finalised in court, with guilty pleas in all cases. 2015 saw the publication of our first Inspectorate Report, highlighting ISPCA initiated prosecutions that were finalised in 2014. This will become an annual publication and will allow us to demonstrate the impact of our Inspectors. We expect many more cases to come before the courts throughout 2016. During the course of their duties our Inspectors seized or had surrendered to them a record number of animals. Over 1100 animals, including 818 dogs, 82 cats and 74 equines were taken into the care of the ISPCA by our Inspectors. This is clear evidence that the Animal Health and Welfare Act, introduced in March 2014, is already having an impact.

Thanks to co-funding from Waterford SPCA and Limerick SPCA, we were able to recruit two new Inspectors in September 2015 to cover Waterford/South Tipperary and Limerick, respectively. We now have eight Inspectors covering 17 counties. Our new Inspectors are already making a big difference to the lives of animals in their respective counties. As a result of the increased number of Inspectors we expect to see many more animals being rescued and more prosecutions being initiated. We aim to recruit more Inspectors in the coming years and our objective is to recruit enough Inspectors to cover the whole of Ireland. In April 2015, the ISPCA had to deal with the largest and most challenging case in our history. Following a joint operation with An Garda Síochána and Carlow County Council, a registered Dog Breeding Establishment was issued with a closure notice and 340 dogs and 11 horses were removed from the property over a nine day period. With such a large number of animals involved we were delighted with the response from our Member Societies who rallied round and assisted in caring for and rehoming the dogs. Thanks to all of the Member Societies and other organisations who assisted with this unprecedented rescue. This case highlighted the importance of working together as a group, something I hope we will see more of going forward. The intensive breeding of dogs and the illegal export of puppies, leading to significant welfare problems, is one of the biggest challenges we face throughout 2016.

Our animal centres continue to go from strength to strength. As former Chairperson Barbara Bent stepped back from supervising our Equine Centre in 2015, we have recruited a new Manager who will grow and develop the team. The Equine Rescue Centre found new homes for over 40 horses in 2015 and 17 rescued donkeys were transferred to the Donkey Sanctuary with which we have built up an excellent relationship. The National Animal Centre found new homes for over 500 dogs, 180 cats and 25 horses.

In 2015, we reduced the number of Dog Warden services managed by the ISPCA from eight to five. This has allowed us to improve the services that we still provide and improve the welfare of all stray and abandoned dogs entrusted to our care. We will continue to review our involvement in Dog Warden services in 2016.

I am very confident that the ISPCA will continue to grow and develop over the coming years. 2015 saw the development of ISPCA's first Strategic Framework, launched in January 2016 which will provide a road map for ISPCA activities over the next five years and beyond. From 2016 to 2020, we will be concentrating on four key animal welfare pillars: Prevention and Enforcement; Education; Responsible Rehoming, and Advocacy for Animals. We will also build foundations to support growth and development in these key areas, including developing the relationships between the ISPCA and its Member Societies to ensure we deliver the best possible services for animals across Ireland.

Finally, I would like to thank the ISPCA Board of Directors for their continued confidence in my leadership. I would also like to thank the staff and volunteers of the ISPCA and Member Societies for their hard work, dedication and compassion without which we could not achieve the tremendous benefits for animals around the country. Of course we could not do anything without our supporters who continue to donate through challenging times. With their ongoing support, the ISPCA and its Member Societies will be able to continue to provide a voice for animals and continue to achieve our objectives of preventing cruelty and alleviating suffering of animals all over Ireland.

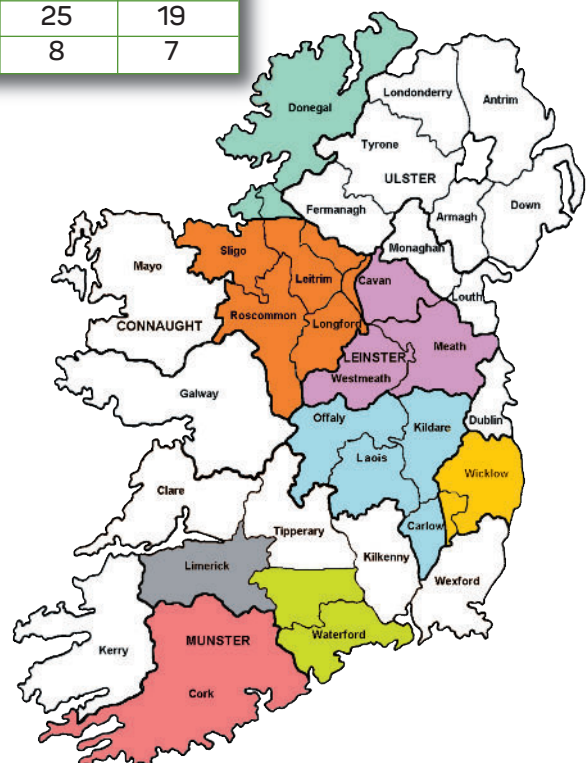

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE IRISH SOCIETY FOR THE PREVENTION OF CRUELTY TO ANIMALS

We have audited the financial statements of The Irish Society for the Prevention of Cruelty to Animals for the year ended 31 December 2015 set out on pages 9 to 27. These financial statements have been prepared under the accounting policies set out in the notes to the accounts.*

This report is made solely to the charity's members, as a body, in accordance with Section 391 of the Companies Act 2014. Our audit work has been undertaken so that we might state to the charity's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charity and its members, for our audit work, for this report, or for the opinion we have formed.

RESPECTIVE RESPONSIBILITIES OF DIRECTORS AND INDEPENDENT AUDITOR

The directors are responsible for the preparation of the financial statements in accordance with applicable law and the accounting standards issued by the Financial Reporting Council and promulgated by Chartered Accountants Ireland (Generally Accepted Accounting Practice in Ireland).

Our responsibility is to audit and express an opinion on the financial statements in accordance with Irish Law and International Standards on Auditing (UK and Ireland). Those standards require us to comply with the Auditing Practices Board's Ethical Standards for Auditors.
